CRITERIA

Award Recipient Requirements

1. Minimum of twenty years of registered membership and service to the College Basketball Officials Association (CBOA).
2. Made significant contributions through their commitment and dedication to support CBOA for the betterment of College Basketball Officiating.

Support Material Guidelines

1. Nomination and application materials must be completed and submitted to the Association's committee chair no later than September 1, of the year which the nominee will be considered.
2. If more than one (1) nominee is submitted by an area, such area will prioritize the nominees.
3. A formal letter of reference will be submitted by the nominee or area representative highlighting the nominee's contributions and commitment to CBOA and College Basketball Officiating.
4. The Area Representative is required to verify the nominees' years of service with the Executive Director.
5. Signature of the nominator, area representative, and executive director is required on the nomination form.
6. Nomination for the Nucatola Award will be considered annually. Nominees not elected may reapply with all necessary support materials being resubmitted for the following year.

Additional Guidelines

1. An individual may not self-nominate for this award.
2. The Nucatola Honorary Life Membership Committee Chair will submit all pertinent and subsequent materials to the CBOA Board of Directors for formal approval.
